EVIDENCE IN SUPPORT OF C.R.C.P. 57 - DECLARATORY JUDGMENT FOR VIOLATIONS OF C.R.S. § 24-6-401, 402 OPEN MEETINGS LAW AND 42 U.S.C. §1983 CONSTITUTIONAL CLAIMS

Plaintiffs, by and through their undersigned counsel, respectfully move this Court to supplement

the record with newly obtained documentary evidence relevant to Plaintiffs' C.R.C.P. 57 - Declaratory

Judgment for violations of C.R.S. § 24-6-401, 402 (Open Meetings Law), and 42 U.S.C. §1983 Constitutional claims under the First and Fourteenth Amendments (Freedom of Speech and Due Process) and requests for declaratory and injunctive relief.

CERTIFICATE OF CONFERRAL: Pursuant to C.R.C.P. 121(c) § 1-15(8), due to the 2:34 PM Saturday 5/31/2025 public posting of this evidence and the imminent nature of a potential ruling, undersigned has attempted to confer in good faith with Defendants' counsel regarding the relief sought by email sent at 8:54 PM on Saturday 5/31/2025. This motion is being filed prior to receiving a response. Plaintiffs will supplement this certificate if a response is received.

INTRODUCTION

This motion seeks to add 55 screenshots of text messages that were publicly disclosed by Darcy Schoening in a Signal group chat during May 2025. These messages involve Defendants Mayor of Palmer Lake Glant Havenar (Glant), Darcy Schoening (Confidant of Glant, then candidate for head of Colorado GOP - not a resident or business owner in Palmer Lake), Mark Waller (former El Paso County Commissioner and paid lobbyist for Buc-ees), Palmer Lake Trustee Shana Ball, and Nina Ruiz, (former El Paso County Planner, Planner Director of Monument, and Senior Executive Consultant for Vertex) were subsequently preserved and authenticated by Dana Duggan, President of Integrity Matters. The messages provide direct evidence of violation of confidentiality of Executive Sessions, ex parte communication and coordination with Mark Waller for applicants, attempts at manipulation of votes and hearings, speaker control - including directing substance of petitioner's remarks by Mayor, retaliation against political opponents and viewpoint discrimination, use of public office to suppress free speech of citizens and to attempt to prevent citizens of Monument, Colorado, specifically Mayor Pro Tem Steve King, from attending Palmer Lake Board of Trustee meetings and speaking. Although Plaintiffs no longer seek relief under Rule 106(a)(4) as to the December 12, 2024 vote due to subsequent withdrawal of the annexation petition, the underlying claimsthe claims regarding the May 29, 2025, annexation eligibility hearing remain live. Plaintiffs also continue to pursue declaratory and injunctive relief based on First and Fourteenth Amendment violations and violations of Colorado's Open Meetings Law (C.R.S. § 24-6-402). The newly discovered messages support those claims.

Plaintiffs respectfully request that this Court supplement the record with these materials so that they may be considered in connection with Plaintiffs' surviving claims.

II. LEGAL STANDARD

While review under C.R.C.P. 106(a)(4) is typically limited to the administrative record, Colorado courts allow supplementation when necessary to show bias, improper conduct, or procedural unfairness. See *Board of County Comm'rs v. O'Dell*, 920 P.2d 48 (Colo. 1996). Further, Plaintiffs' constitutional and statutory claims are not restricted to the administrative record and may be supported by any relevant evidence.

C.R.E. Rule 401 defines "relevant evidence" means evidence having any tendency to make the existence of any fact that is of consequence to the determination of the action more probable or less probable than it would be without the evidence.

This evidence establishes direct evidence proving clear violations of Colorado's OML and 42 U.S.C. 1983 Constitutional violations among other allegations:

• Mayor Glant Havenar's long term and repeated ex parte contacts with Mark Waller, the

petitioner's representative.

- Glant's ex parte communication and coordination with Mark Waller, on behalf of applicants, of process, meetings and hearings related to annexation petition, including remotely driving comments at public hearings
- Havenar's bias and prejudgment declaring that the vote will be 4 1 before and during the hearing
- Procedural unfairness Havenar coordinated the hearings and statements in advance with Waller and attempted to limit public comment to exclude citizens in opposition in a prima facie case of viewpoint discrimination
- use of public office to suppress free speech of citizens and to attempt to prevent citizens of Monument, Colorado, specifically Mayor Pro Tem Steve King, from attending Palmer Lake Board of Trustee meetings and speaking.
- Attempts to limit comments to only one hour, the minimum required by statute, despite the significance of the matter at hand
- Darcy Schoening's (Darcy) presence as the eyes and ears of the Mayor who was supposedly out of the country
- Darcy's preferential admission to 12/12/2024 hearing to run things on Glant's behalf
- violation of confidentiality of Executive Sessions,
- attempts at manipulation of votes and hearings,
- deliberate attempts at controlling speakers comments including directing substance of petitioner's remarks re. contiguity

- retaliation against political opponents and viewpoint discrimination,
- Manipulation of public comment on social media through false profiles including "Samantha Stewart" texts show Glant admitting creation of this profile
- Knowing violation of ethics rules regarding conflict of interest and duty to recuse from votes due to Glant receiving financial benefit from applicants

C.R.E. Rule 901. Requirement of Authentication or Identification outlines the procedures for authentication as Plaintiffs have done here by Dana Duggan, President and Founder of Plaintiff Integrity Matters.

III. DESCRIPTION OF EVIDENCE

Attached as Exhibits A-1 through A-55 are screenshots of group messages and texts from public officials. These include:

- Real-time vote prediction and coordination with a developer representative during public hearings
- Retaliatory and vulgar commentary about named citizens
- Manipulation of public discourse through impersonation and selective blocking
- Discussion of petition signers and organizers in threatening or defamatory terms

This evidence is indexed in a separate exhibit index and authenticated by a sworn declaration from Dana Duggan, filed concurrently.

IV. REQUEST FOR RELIEF

WHEREFORE, Plaintiffs respectfully request that the Court grant this Motion to Supplement the Record and accept Exhibits A and A-1 through A-55 as part of the record in support of Plaintiffs' claims for violations of C.R.S. § 24-6-401, 402 Open Meetings Law and 42 U.S.C. §1983 Constitutional Claims relating to Freedom of Speech and Due Process under the First and Fourteenth Amendments.

1. Personal Background:

I am a resident of Colorado Springs, Colorado, and over 18 years of age. I have personal knowledge of the facts stated herein.

2. I attest that beginning on Saturday, May 31st, 2025, Darcy Schoening began posting into a Signal group chat of over 100 people across the state, many screenshots of text messages that include messages with Buc-ee's consultant Mark Waller, Mayor of Palmer Lake Glant Havenar and Ms. Schoening. This continued through the evening of Sunday, June 1st, 2025 until she deleted the posts claiming she "accidentally" posted them intending to put them in a folder. Below is a list of those texts and relevance:





Image 3650 - Darcy Schoening & Mayor Glant Havenar discuss a vote conflict for the Mayor due to financial benefit

Mayor Havenar believes she should be able to vote on a town issue, and Buc-ee's consultant Mark Waller and the town attorney, Scott Krob think she is able to vote. Assuming the 3 days left would imply three days before the election, in which Mayor Havenar won by a slim margin.

The hearing started at 6pm, and statutory requirements for an annexation hearing is one hour of testimony. Mayor Havenar and Darcy Schoening want to have the hearing end at one hour only to fulfill the requirements. Well over 100 people are present at the meeting, although only about 40 were allowed inside at one time, giving preference to residents of Palmer Lake over those who live adjacent to the proposed annexation. The others were forced to wait outside in freezing temperatures. Bill Wysong is an El Paso County Commissioner and was called to testify but inadvertently signed the sheet to speak and left before this point in the hearing.






Image 3673 - Allegations of Buc-ee's paying \$20,000 to stop the Recall and Ballot Initativ





